U.S. Border Control Takes Action to Stop the Spread of "Creeping Shari'ah Law"

LEGAL BATTLES IN DEFENSE OF FREEDOM

U.S. Border Control and U.S. Border Control Foundation filed suit in Oklahoma to defend that state's right to pass an amendment ensuring that only American laws would be used to decide cases brought in Oklahoma courts.

The amendment was introduced because of a growing number of instances where Muslims have attempted to use Shari'ah law in defense of their actions.

The effort to prevent the amendment from being certified was led by CAIR (Council on American-Islamic Relations), an organization alleged to

have ties to the terrorist group Hamas. The amendment, which was passed overwhelmingly on Nov. 2, 2010, would ensure that only U.S. laws, including the United States Constitution, the Oklahoma Constitution, the United States Civil Code, established common law and Oklahoma Statutes could be allowed in its courtrooms.

Why is this an issue? Because Shari'ah law appears to be backward and brutal system that treats women like cattle; condones violence, even murder; and denies freedom of both speech and religion to anyone who is not a Muslim.

That's a real problem for a nation that respects the rights of women and is recognized worldwide as a bastion for

freedom of speech and religion. Sadly, Shari'ah law is already here. In New Jersey, a man who was brutalizing his wife, torturing her and raping her, used Shari'ah Law as his defense.

The Defendant claimed he was "operating under his belief [Shari'ah] that, as a husband, his desire to have sex when and whether he wanted to, was something that was consistent with his practices and it was something that was not prohibited."

Everything this country stands for: freedom of speech; freedom of religion, equality and justice are all threatened by Shari'ah law. Your [support](#) today will ensure we have the resources necessary to fight this case all the way to the U.S. Supreme Court, if necessary.

Virginia State Police, Arlington County, Va., police and Metropolitan Washington Airports Authority police said Muhammad Teshale, 25, drove his SuperShuttle van at speeds of 90 to 95 mph on 55 mph roads and struck at least six other vehicles Monday morning between Arlington, Va., and Dulles International Airport.

Teshale was arrested at the airport's main terminal and charged with one count of hit and run with other charges pending. Authorities said the driver told arresting police he "did it to be famous."

Just two months ago, a U.S.-born jihadi-wannabe published this in a New Jihad mag encouraging Muslims to mow Americans down with trucks:

"The idea is to use a pickup truck as a mowing machine, not to mow grass but mow down the enemies of Allah."

Three Iranians Indicted By Portland Federal Grand Jury For Fraud, Money Laundering

Three Iranians living in Texas were indicted by a federal grand jury in Portland for illegally funneling money to Iran, U.S. District Court officials said today.

Hossein Lahiji, 47, of McAllen, Texas, Najmeh Vahid, 35, of San Antonio, Texas and Ahmad Iranshahi, 53, of Tehran, Iran, were indicted for conspiracy to defraud the United States and conspiracy to commit money laundering.

In a news release, federal officials said the three transferred Lahiji's and Vahid's purported donations totalling more than \$1.8 million to the Portland charity the Child Foundation, investing the funds in Iran in violation of the U.S.'s Iranian embargo.

Lahiji and Vahid, a married couple, retained interest and control in Iran over a significant part of the transferred funds, but then claimed them as deductions to reduce their U.S. income tax liability. Lahiji and Vahid are scheduled to appear in U.S. District Court in San Antonio ext week. Iranshahi is a fugitive.

"It is imperative that the donating public have confidence that charities providing overseas services, are operating in compliance with all applicable U.S. laws," said U. S. Attorney Dwight Holton. "These defendants are charged with going to extraordinary lengths to conceal the transfer of large sums of money in violation of the trade restrictions with Iran that have been in place for well over a decade. This prosecution will help restore confidence in the integrity of charities."

Federal court officials said the defendants funneled the cash through Swiss bank accounts, and disguised cash transfers as food commodities from the United Arab Emirates.

Further, the indictment alleges, the Child Foundation provided funds "for a large portion of the overhead and operational expenses in Iran. Iranshahi, the head of a related Iranian entity, took control of the funds once they reached Iran, and provided deceptive records and receipts for auditors and regulators in the U.S."

Official said the charge of conspiracy to defraud the United States carries a maximum penalty of 5 years in prison and a \$250,000 fine. The conspiracy to commit money laundering has a maximum penalty of 20 years imprisonment and a \$500,000 fine. Bean-Bags vs. AK-47s worldnet daily

Another Border Patrol agent on the Arizona border was shot and killed by Mexican drug smugglers last Tuesday. Of the eight attackers, four are in custody and a fifth is under surveillance by Border Patrol Blackhawk helicopters as he tries to make his way back to the Mexican border.

BP Agent Brian Terry was part of a BORTAC team (for border tactical unit) tracking armed drug smugglers 15 miles northwest of Nogales, Ariz., (and only three miles west of Interstate 19) when they were attacked with automatic weapons fire. The area is well-known as a major drug-smuggling corridor, and the smugglers are known to frequently be armed with AK-47s and other long rifles.

Sadly, the "rules of engagement" call for using ("non-lethal") bean-bag rounds first before using live ammunition. And this is how Agent Terry was killed.

Here's the part Homeland Security Secretary Janet Napolitano and Border Patrol management are trying to hide: Border Patrol Agent Terry and the BORTAC team were under standing orders to always use bean-bag rounds first. When the smugglers heard the first rounds, they returned fire with real bullets, and Agent Terry was killed in that exchange. Real bullets outperform bean-bags every time.

Clearly, the rules of engagement and inadequate weaponry of the Border Patrol place the lives of all agents

at grave risk. The National Border Patrol Council, which represents over 15,000 field agents, believes the border is far too dangerous for officers to patrol without body armor, armored vehicles and automatic weapons.

Why is this nonsense happening? The sad truth is that Washington is putting the lives of brave border patrol agents at risk in the name of political correctness. They are worried that an "innocent" illegal alien could get shot.

The BORTAC team encountered not one or two smugglers but a team of eight. Four are in custody, one is under surveillance in the rugged terrain of the Pajarita Wilderness area east of the small ranch town of Ruby, and three others are missing. The captured smugglers had AK-47s and backpacks filled with ammunition, food and radios.

The rules requiring first use of bean-bag ammunition is but one example of the suicidal rules of engagement that govern Border Patrol operations.

Other rules that make law enforcement impossible include: Border patrol agents in "hot pursuit" of smugglers may not exceed the speed limit! And Border agents are told not to pursue suspects attempting to leave the country. Thankfully, border agents who want to stop crime, smuggling and illegal immigration routinely put their careers at risk by ignoring such stupid rules.

Hezbollah Terrorists Are Slipping Into U.S. Through Mexican Border Tunnels

Inside Mexican Drug Tunnel With A Railway

A sophisticated cross-border tunnel - equipped with a rail system, ventilation and fluorescent lighting - has been shut down by U.S. and Mexican officials.

This was the second such tunnel discovered in San Diego in just one short month, authorities said today.

The tunnel is 2,200 feet long and runs from the kitchen of a home in Tijuana, Mexico, to two warehouses in San Diego’s Otay Mesa industrial district.

The cinderblock-lined entry to the tunnel dropped 80 to 90 feet to a wood-lined floor.



From the U.S. side, there was a stairway leading to a room about 50 feet underground that was full of marijuana.

Police seized more than 20 tons of marijuana, and reported that the tunnel - and another found in early November - are the work of Mexico’s Sinaloa cartel, headed by the country’s most-wanted

drug lord, Joaquin ‘El Chapo’ Guzman.

Authorities think ‘...ultimately they are controlled by the same overall cartel but that the tunnels were being managed and run independently by different cells operating within the same organisation.’

The newly discovered passage is one of the most advanced to date, with sophisticated construction and a rail system for drugs to be carried on a small cart.

Three men were arrested in the United States, and the Mexican military raided a ranch in Mexico and made five arrests in connection with the tunnel, authorities said.
